WEREAS, Judy Fredericks is an enrolled member of the Three Affiliated Tribes and does own the following tracts of land held in trust for which she has made an application to have said lands placed into fee patent status:

NW1, NE1, Section 8, Township 148 N., Range 89 W., McLean County

Lot 2, SW¼ NE¼, Section 6 of Township 147 N., Range 88 W., McLean County

WHEREAS, said application has been reviewed by the Natural Resource Committee;

NOW THEREFORE BE IT RESOLVED that the Three Affiliated Tribes does waive the fee patent to the above described property and will not make any offer to purchase said property.
