RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and authority under said Act; and
- WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribes and tribal members; and
- WHEREAS, Members of the Three Affiliated Tribes are ineligible to participate in direct loans from Title I and guaranteed loans from Title II of the Indian Finance Act of 1974, where the Tribal Business Council operates a Relending Loan Program; and
- WHEREAS, The Three Affiliated Tribes no longer desires to operate a relending credit program and would rather participate in the Direct Loan Program available through the Indian Financing Act of 1974; and
- WHEREAS, There is an upaid balance of \$90,000.00 in the current Relending Program; and
- WHEREAS, \$60,886.05 will be paid back immediately and the balance of approximately \$30,000.00 will be paid back over 3 years at \$10,000.00 per year, plus interest from the line item Relending Repayment BIA in the annual Tribal Budget.
- WHEREAS, The Tribe had developed a plan to qualify for and participate in said direct loan program; and
- WHEREAS, The Tribe is fully eligible to participate in said direct loan program; and
- NOW, THEREFORE, BE IT RESOLVED, that the Three Affiliated Tribes herein requests that the Three Affiliated Tribes and its membership be declared eligible for the United States Direct Loan Program under the Indian Finance Act of 1974.
- BE IT FURTHER RESOLVED that the Three Affiliated Tribes, by this Resolution, adopts the Plan of Operation for the Direct Loan Program.
- BE IT FURTHER RESOLVED that the Three Affiliated Tribes no longer desires to participate in the Relending Program and will pay the current indebtedness by 1987, and the Chairman is authorized to sign a General Assignment of Income for the current indebtedness.
- BE IT FURTHER RESOLVED that the Bureau of Indian Affairs allocate \$800,000.00 to implement this Direct Loan Program.
