WHEREAS, Gainus Little Soldier is an enrolled member of the Three Affiliated Tribes and does own the following tracts of land hald in trust for which he has made an application to have said lands placed into fee patent status:

SW¼,SE¼,W½,NW¼,SE¼ of Section 19, SW¼,SW¼, of Section 20, Township 147, North of Range Eighty-nine, West of the Fifth Principal Meridian in Mercer County, North Dakota, Containing 100.00 acres.

WHEREAS, said application has been reviewed by the Natural Resource Committee;

NOW THEREFORE BE IT RESOLVED, That the Three Affiliated Tribes does waive the fee patent to the above described property and will not make any offer to purchase said property.




