WHEREAS, the Tribal Business Council at the Regular Meeting on February 9, 1984 has agreed by motion to modify the tribal budget by deleting, shortening or creating account(s); and

WHEREAS, there exists within the tribal budget/programs funded from existing Docket Fund monies totaling \$84,288.68:
