- WHEREAS, This Corporation is an Indian Chartered Corporation as defined by the Indian Reorganization Act of June 18, 1984; and authority is granted under said Act, and
- WHEREAS, The Constitution and Corporate Charter of the Three Affiliated Tribes authorizes the Business Council of the three Affiliated Tribes to enact laws for the benefit of the people, and
- WHEREAS, There has been a genuine interest of tribal members active in the local, GPIRA, and other rodeo associations to establish a Rodeo Club on the Fort Berthold Reservation under the auspices of the J-S Ranch in Mandaree,
- WHEREAS, The J-S Ranch has the facilities to sponsor such a club, including: stock, concessions and indoor arena, and has made arrangements to insure the safety of the participants as well as security,
- WHEREAS, The Spotted Horn Store, also under the auspices of the J-S Ranch, serves tribal members by providing commercial credit to its customers for necessities, gas, food, etc.
- NOW, THEREFORE, LET IT BE RESOLVED THAT, the Tribal Business Council Business Council of the Three Affiliated Tribes does hereby issue a Tribal Liquor license to Rose Stone, an enrolled member of the Three Affiliated Tribes, for the period of one (1) year from this date, for the off-sale of beer only at the Spotted Horn Store during business hours.
- BE IT FURTHER RESOLVED, that the J-S Rode Club be issued a special liquor license for the on-sale of beer only, to Rose Stone, an enrolled member of the Three Affiliated Tribes, for their sanctioned functions, to be sold only to card-holding members of the J-S Rodeo Club.
