- THEREFORE BE IT RESOLVED, that the Tribal Business Council approves the partitionment of lands held in trust by the United States of America for the
  Three Affiliated Tribes and lands held in trust by the United States of
  America for John Silas Burbank, 301-A1725 under terms and
  conditions as stated below and hereby authorizes the Chairman of the
  Tribal Business Council, its Secretary, the Superintendent of the Fort
  Berthold Reservation, the Area Director, and the Commissioner of Indian
  Affairs to prepare all documents and do all things necessary to partition
  lands for which title is to be transferred to the United States of America
  in trust for the Three Affiliated Tribes and John Silas Burbank,
  301-A1725 under the terms and conditions as stated below:
- Three Affiliated Tribes will own that part of Allot. No. 755A E½NE¼, NE¼SE¼, W½SE¼SE¼, Sec. 19, T. 149 N., R. 93 W., fifth principal meridian, North Dakota, containing 140.00 acres, more or less, exclusive of minerals.
- John Silas Burbank will own that part of Allot. No. 755A NE4SE4SE4, N2SE4SE4SE4, Sec. 19, T. 149 N., R. 93 W., fifth principal meridian, North Dakota, containing 15.00 acres, more or less, exclusive of minerals.
