# RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, the Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and
- WHEREAS, the Three Affiliated Tribes is an eligible government under the General Revenue Sharing Program regulations State and Local Fiscal Assistance Act of 1972 (PL 92-512) (As amended PL 94-488); and
- WHEREAS, the Office of Revenue Sharing of the US Department of Treasury has notified the Three Affiliated Tribes (Revenue Sharing Account No. 35 6 013 325) in a Recipient Account Statement that its Allocation for Fiscal Year 1984 is \$62,439.00; and
- WHEREAS, the Revenue Sharing Allocation is transmitted to the Three Affiliated
  Tribes on a quarterly basis \$15,609 at each of the first three quarters
  and \$15,612 in the final quarter; and
- WHEREAS, the Three Affiliated Tribes must make certain assurances and follow the Office of Revenue Sharing's Public Participation and Reporting Requirements; and
- WHEREAS, The Tribal Business Council of the Three Affiliated Tribes has during the months of February, March, and April implemented the public participation requirements; and
- WHEREAS, the Tribal Business Council is required to adopt an FY 1984 Revenue Sharing Budget as the basis for the distribution of the \$62,439.00 allocation; and
- WHEREAS, at the March 22, 1984 a Tentative Revenue Sharing Budget was adopted where by each Reservation Community would receive an allocation of \$10,000.00 (Total of \$60,000) and the Tribal Business Council would retain \$2,439.00 for Revenue Sharing Administrative Costs and special requests; and
- WHEREAS, each Reservation Community was directed to present a Community Revenue Sharing Budget at the Official Budget Hearing,
- THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes does hereby officially adopt the following FY 1984 General Revenue Sharing Program Budget and the attached Community Budget Allocation Breakdowns:

East Segment/White Shield Community = \$10,000
Northeast Segment/Parshall Community = \$10,000
North Segment/New Town Community = \$10,000
West Segment/4 Bears Community = \$10,000
West Segment/Mandaree Community = \$10,000
South Segment/Twin Buttes Community = \$10,000
Tribal Business Council = \$2,439
