- WHEREAS, The Three Affiliated Tribes Human Resources Department is established to increase the Three Affiliated Tribes Tribal Business Council capabilities of providing more accessible, effective, and diversified Health and Human Services; and
- WHEREAS, The Three Affiliated Tribes Tribal Business Council recognizes the importance of nutrition support services that Sister Anna Rose Ruhland provides to many Tribal departments and Tribal Members through the Human Resources Department; and
- WHEREAS, The Three Affiliated Tribes Tribal Business Council supports and realizes the need to continue the employment of this valuable employee.
- NOWETHEREFORE BE IT RESOLVED, that the Three Affiliated Tribes Tribal Business Council authorizes Sister Anna Rose Ruhland to be paid \$5,574.00 from T 2 Budget for a period of 63 days.
  - BE IT FURTHER RESOLVED, that the period of employment will be from October 01, 1984, to December 31, 1984.
