RESOLUTION OF THE GOVERNING BOARD  
OF THE THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and under the authority of said Act; and

WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to manage all economic affairs and enterprises of the Three Affiliated Tribes of the Fort Berthold Reservation in accordance with the terms of a charter to be issued to them by the Secretary of Interior; and

WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to negotiate with the Federal, state and local governments on behalf of the Tribes that may affect the Fort Berthold Reservation; and

WHEREAS, the North Dakota Community Development Block Grant Program Distribution Statement Fiscal Year 1984 prioritizes the distribution and uses of funds under this program:

- ° to provide decent housing, especially to families of low and moderate income, by improving the condition of existing housing stock;
- ° to insure as much flexibility and discretion as possible for eligible jurisdictions to design and implement projects which meet local housing priorities;
- ° to encourage local applicants to use limited funds to complement the use of other public and private funds with resources;
- ° to address Congressional program intent and existing Federal law; and

WHEREAS, the Three Affiliated Tribes is eligible to participate in the North Dakota Community Development Block Grant Program as a second party; and

WHEREAS, the Housing and Community Development Act of 1974 emphasizes the importance of partnership and coordination between private and public sector entities, and especially low-income minority residents of local communities; and

WHEREAS, the City of Parshall, an eligible applicant as an incorporated community in the State of North Dakota is willing to cooperate with the Three Affiliated Tribes and the Souris Basin Planning Council, in preparing an Housing Rehabilitation grant application in behalf of the low and moderate income families residing in the City of Parshall.

THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes authorizes this effort to improve the economic well-being of the City of Parshall's economically disadvantaged citizens; and



CERTIFICATION


