RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribes and Tribal Members; and
- WHEREAS, It is the responsibility of the Three Affiliated Tribes Tribal Business Council, through their Human Resources Depeartment, to increase their capabilities of providing more accessible, effective, and diversified Health Services, that will enhance and maximize Tribal Members capabilities, for greater self-sufficiency and well being; and
- WHEREAS, The Three Affiliated Tribes has not updated its Indian Health Service Tribal Specific Health Plan since 1980; and
- WHEREAS, Said document contained serious omissions of considerations of alternatives beyond Indian Health Service funding; did not make policy recommendations; did not contain any implementation steps for management for follow-up to its goals; and, overall, is too narrow in scope; and
- WHEREAS, These deficiencies resulted in the said document possessing little usefulness beyond the Three Affiliated Tribes completing a funding step for Indian Health Service; and
- WHEREAS, The Three Affilaited Tribes has recognized the value of Comprehensive Planning and Management by its implementation of that process with all Tribal Departments; and
- WHEREAS, The final product of the Three Affiliated Tribes Comprehensive Health Distribution Plan could well serve as a model for other Tribes in the Aberdeen area who desire a truely Comprehensive Analysis of the Health Need/Concerns; and
- WHEREAS, It is imperative that the Health Sector of the Three Affiliated Tribes Comprehensive Plan receive sufficient study and consideration; and it realize that additional financial assistance is required to provide a truly comprehensive analysis; and
- WHEREAS, The Indian Health Service, Aberdeen Area Office, Aberdeen, SD has indicated that funding for this purpose could be made available through the submission of a suitable proposal by the Three Affiliated Tribes; and
- NOW, THEREFORE, BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes authorized and directs Mike Yellow Bird, Human Resources Department Administrator; and Ken Deane Jr., Management Assistant Specialist; to develop and submit the above referenced proposal to the Aberdeen Area Office of the Indian Health Service.
- BE IT FURTHER RESOLVED, That any funds considered for this proposal shall not be funds now or in the future allowed for Contract Health Care or Health Services provided for the Fort Berthold Reservation.
