- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution and By-laws of the Three Affiliated Tribes authorize and empower the Tribal Business Council to engage in activities for the welfare and benefit of the Tribes and tribal members; and
- WHEREAS, The Tribal Finance Office is having difficulties with their Indirect Cost budget due to deficit accrued costs; and
- WHEREAS, The Tribes will correct this deficit with a loan obtained utilizing their lease incomes for collateral; and
- NOW, THEREFORE BE IT RESOLVED, That the Tribes sign an "Assignment of Income" with the American Indian National Bank in the amount of \$400,000.00 to be repaid over a five (5) year period, at \$80,000.00 per annum plus accrued interest.
