

RESOLUTION OF THE GOVERNING BODY OF
THE THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and tribal members; and

WHEREAS, A Regular Meeting was called on April 11, 1985; and

WHEREAS, According to Article II, Section 1: Membership, The membership of the Three Affiliated Tribes shall consist of:

- A. All persons whose names appear on the membership of the Tribes as of October 2, 1974
- B. Any person born before the effective date of the amendment and to any member of the Tribe who was a resident of the reservation at the time of birth of said person.
- C. All persons of at least 1/4 degree Indian blood of a federally recognized Tribe, provided that at least 1/8 Indian blood be of the Hidasta, Mandan and/or Arikara Tribes.

AMENDMENT VII, DUAL ENROLLMENT

A. Persons enrolled with another Tribe and who have received benefits from such Tribe in the form of land or payments shall not be eligible for enrollment with the Three Affiliated Tribes of the Fort Berthold Reservation, provided that inherited interests shall not be considered as being such benefits.

B. A person eligible for enrollment with the Three Affiliated Tribes of the Fort Berthold Reservation shall relinquish whatever rights he or she may hold in the other Tribe as a condition of his or her enrollment with the Three Affiliated Tribes of the Fort Berthold Reservation.

WHEREAS, This amendment became effective 12:00 A.M., December 12, 1975; and

WHEREAS, Diana L. Corn Kostamo had requested relinquishment of membership from the Three Affiliated Tribes of the Fort Berthold Reservation; and

WHEREAS, Diana L. Corn Kostamo was granted her request of relinquishment upon the confirmation she was eligible for enrollment with the Menominee Tribe of Wisconsin through the Tribal Business Council approval of Resolution #80-121, dated the 10th day of July, 1980; and

WHEREAS, Diana L. Corn Kostamo has notified the enrollment office of her desire to be reinstated with the Three Affiliated Tribes through the advisement of her mother; and

WHEREAS: Diana L. Corn Kostamo, recognizing the error of her judgement, has decided to withdraw her application of enrollment with the Menominee Tribe of Wisconsin; and

WHEREAS: Diana L. Corn Kostamo wishes to enroll her son with the Three Affiliated Tribes upon her reinstatement.

NOW, THEREFORE BE IT RESOLVED: That the Tribal Business Council hereby disapproves the reinstatement of membership of Diana L. Corn Kostamo.
