

RESOLUTION OF THE GOVERNING BODY OF
THE THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, the constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, in order to be eligible for future Indian Health Service and Home Improvement Program funding, the Bureau of Indian Affairs has required that each Reservation conduct a Housing Inventory and,

WHEREAS, the Three Affiliated Tribes Material Resource Department has conducted a Housing Inventory and,

WHEREAS, the Three Affiliated Tribes' Tribal Council's Material Resource Committee on May 1, 1985 approved the Consolidated Housing Inventory Report and,

WHEREAS, the Bureau of Indian Affairs Aberdeen Area Office has informed us a Tribal Resolution is needed certifying the Housing Inventory,

NOW, THEREFORE BE IT RESOLVED, that the attached Consolidated Housing Inventory is true and correct to the best of our knowledge and it adequately states the needs of the Fort Berthold Indian Reservation.

CERTIFICATION

I, the undersigned, as Secretary of the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation, hereby certify that the Tribal Business Council is composed of 11 members, of whom 7 constitutes a quorum, 11 were present at a Regular Meeting thereof duly called, noticed, convened, and held on the 9th day of May 1985; that the foregoing Resolution was duly adopted at such Meeting by the affirmative vote of 11 members, 0 members opposed, 0 members abstained, 0 members not voting, and that said Resolution has not been rescinded or amended in any way.
