# RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and
- WHEREAS, The Three Affiliated Tribes of the Fort Berthold Reservation is an eligible recipient government of entitlement funds under the Revenue Sharing Act, 31 U.S.C. 6701 to 6724, as Amended; and
- WHEREAS, The Office of Revenue Sharing of the US Department of Treasury has notified the Three Affiliated Tribes (Revenue Sharing Account Number 35 6 013 325) in a Recipient Account Statement that its Allocation for Fiscal Year 1985 is \$55,708.00 (\$13,927 Quarterly); and
- WHEREAS, Recipient governments are required to comply with the regulations contained in 31 CFR Part 51, which implement the Revenue Sharing Act and include public participation, public notice, reporting, and other requirements; and
- WHEREAS, The Tribal Business Council of the Three Affiliated Tribes has during the months of April and May implemented the public participation requirements; and
- WHEREAS, The Tribal Business Council is required to adopt an official Fiscal Year 1985 Revenue Sharing Budget by resolution to serve as the basis for the distribution of the \$55,708.00 allocation; and
- WHEREAS, Each Community was directed to present a Community Revenue Sharing Budget at the Offical Budget Hearing;
- THEREFORE BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes does hereby officially adopt the following FY 1985 General Revenue Sharing Program Budget and the attached Community Budget Allocation Breakdowns:
  - \$5,952 South Segment/Twin Buttes Community
  - \$5,952 West Segment/Mandaree Community
  - \$5,952 West Segment/Four Bears Community
  - \$5,952 North Segment/New Town Community
  - \$5,952 Northeast Segment/Parshall Community
  - \$5,952 East Segment/White Shield Community
  - \$5,000 Audit Costs
  - \$2,000 Indian Day Costs
  - \$2,496 Commodity Program Inventory Claim
  - \$4,500 White Shield Complex Electric Bill Overrun
  - \$4,500 Program/Salary Claims
  - \$1,000 Reservation Veterans Memorial
  - \$ 500 KMHA Television Interference Costs
  - \$55,708 AVAILABLE TOTAL FOR FY 1985

Ron Smith was on hand to explain about the new road to be built in the Villarea. Poitra Construction will build this road. Karen Smith motioned to get speed bumps or dips on this new construction for safety reasons. Hazel Heart seconded motion and it passed 12 for none opposed.

Jean Hall was on hand to request the Drags Wolf Community to put in some washers and dryers in the Community Hall which could benefit many community people. This is being done because of the high cost to wash in New Town and that it would be economically better for the people in this raea. She explained what Housing is doing in the Elderly Homes also. Ron Smith motioned to appoint a committee to get this laudromat started. Alyce Spotted Bear seconded motion and it passed. 12 for none opposed. Alyce Spotted Bear, Terry Price, Ron Smith, Rose Crow Flies High, and Jean Hall are appointed to this committee. Karen Smith motioned to approve this committee and Norma Staples seconded motion. 12 for none opposed.

Chairman gave her report on the diabetics at the clinic. Our community should help them if we can. After more discussion, Karen Smith motioned to have the community donate \$200 to help the Diabetics Clinic. Pat Black Hawk seconded motion and it passed. 11 for none opposed

Chairman mentioned that we should start a Youth Program. Discussion was held on this topic. Another topic discussed was on the dumping of garbage behind the Village area. Pat Black Hawk also mentioned that there are qualified people to run the front -end loader and backhoe. To could be used to bury the garbage that someone is dumping. After more discussion, Karen Smith motioned to have a community cleanup program on Friday the 17th. 5 pm to 8 pm. Pat Black Hawk seconded motion. At this time, discussion was held on the Revenue Sharing Funds that each community will receive. After some discussion, Karen Smith motioned to use 1.000 of this amount to pay Eagle Construction. Alvce Spotted Bear seconded motion and it passed. 10 for none opposed. Alvce motioned to place remaining Revenu Sharing Funds in General Operating Expenses. Pat Black Hawk seconded motion and it passed. 10 for none opposed.

Secretary informed meeting on the progress of the bingo program. We will continue to hold games until nobody wants them or we don't have the funds to continue. He also informed meeting on Eye Glass Program.

Alyce Spotted Bear motioned to set aside \$200 for a Youth Program for 2 age groups. Karen Smith seconded motion and it passed. 11 for none oppose

After Chairman mentioned that Don Rush was to be at this meeting but didn't make it and wanted some assistance for the Memorial Run, Norma Staples motioned to donate \$100 for this Run. Ron Smith seconded motion and it passed. 7 for none opposed.

Karen Smith motioned to appoint Darryl Baker. Tony Halvorson. Ron Smith. and Pat Black Hawk to approach Material Resources for use of the Utilities equipment for burying the garbage dump. Hazel Heart Seconded motion a it passed.

Karen Smith wanted an emergency loan until payday, Friday the 10th. Hazel Heart motioned to approve this loan. Pat Black Hawk seconded motion and it passed. 8 for none opposed.

Hazel Heart motioned to adjourn meeting. Karen seconded motion and it passed. 8 for none opposed. Meeting over at 10 P.M..
