- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and Tribal members; and
- WHEREAS, Article VI, Section 5(b) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to create and maintain a Tribal Business Council fund; and
- WHEREAS, Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer any funds within the exclusive control of the Tribes; and
- WHEREAS, The Tribal Business Council has recognized the need to budget additional fringe costs;
- NOW, The Tribal Business Council hereby approves Revision 2 of the FY1986 T2 Expense Budget (a true and correct photostatic copy of which Revision is attached hereto and made part hereof), dated 24 January 1986.
- BE IT FURTHER RESOLVED, That this Resolution does not change the total amount to be requested from the U.S. Government.
- BE IT FURTHER RESOLVED, This Resolution rescinds Resolution #85-203-C in its entirety.
