WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

- WHEREAS, The Bureau of Indian Affairs Fort Berthold Agency has notified the Three Affiliated Tribes Natural Resources Department that monies for a water development project are available for contracting; and
- WHEREAS, The Natural Resources Department does desire to contract the project for the Tribe and has developed a plan and budget; and
- NOW THEREFORE BE IT RESOLVED, That the Three Affiliated Tribes does hereby approve the Natural Resources Department Proposal for P.L. 93-638 Contract for Water Development; and
- BE IT FURTHER RESOLVED, That the Natural Resources Department will administer the contract and that any member of the Executive Committee shall be authorized to sign said contract on behalf of the Three Affiliated Tribes.

100.1 - CONTRACT AUTHORITY: This contract is authorized by P.L. 93-638 and U.S.C. 13.

100.2 - PURPOSE: The contractor will provide needed water develops such as stock dams, spring development, water wells for livestock use, etc, in Range Units within the Fort Berthold Indian Reservation.

100.3 - SCOPE: The contractor will develop and administer the Agricultural and Range Improvement Water Development Project as necessary to meet the Purpose of the contract.
