

RESOLUTION OF THE GOVERNING BODY OF
THE THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION

- WHEREAS, This Nation, having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, the Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and
- WHEREAS, under Section 533 of the Housing Act of 1949 [42 USC 1490 (m)] the Farmers Home Administration has set forth policies and procedures to provide funds to eligible applicants to conduct housing preservation programs benefiting very low- and low-income rural residents; and
- WHEREAS, under 7 CFR 1944.656 & .658, Tribal Governments are eligible to apply and compete for FmHA Housing Preservation Grant (HPG) assistance; and
- WHEREAS, the need exists on the Fort Berthold Reservation for improvements to the sub-standard single-family housing units of very low- and low-income homeowners; and
- WHEREAS, the Three Affiliated Tribes Material Resource Department has the necessary experience and expertise in housing repair and rehabilitation activities to properly administer a Housing Preservation Grant; and
- WHEREAS, to compete for HPG Financial Assistance, the Three Affiliated Tribes are required to submit a PreApplication For Federal Assistance Form AD-621 and Supporting Information to the FmHA Reservation Office Director; and
- WHEREAS, the regulations under 7 CFR Part 1944 require that certain forms, assurances, and certifications are included as a part of the Pre-Application
- THEREFORE BE IT RESOLVED, that the Tribal Business Council of The Three Affiliated Tribes hereby authorizes and directs the Material Resource Department to execute and file a Pre-Application for Financial Assistance under the Farmers Home Administration's 1986 Housing Preservation Grant Program.
- FURTHER RESOLVED, that Alyce Spotted Bear, Tribal Chairman is authorized to sign and certify all forms, assurances, and documentation necessary to complete the above referenced submittal.
