

## R E S O L U T I O N

WHEREAS: The Indian Board of Education for the Pierre Indian Learning Center is successfully operating the former Pierre Indian School under a contract through the Indian Self-Determination and Education Assistance Act (PL 93-638) with the U.S. Department of the Interior, Bureau of Indian Affairs, and

WHEREAS: All terms of said contract are being met, and

WHEREAS: The Indian Board of Education is a legal entity within the State of South Dakota, incorporated under South Dakota laws as of April 21, 1972, and

WHEREAS: The Indian Board of Education consists of all Indian members represented by resolution of the fifteen tribes in the Aberdeen Area, and

WHEREAS: The Pierre Indian Learning Center Board of Education is committed to the needs of all of the Indian children of the fifteen (15) Tribes in the Aberdeen Area, and

WHEREAS: The Indian Board of Education for the Pierre Indian Learning Center is carrying out a Special Needs program for children in the Aberdeen Area with multiple social and emotional problems, and

WHEREAS: The Indian Board of Education continues to be vitally interested in these unique services for special need children, and

WHEREAS: The Indian Board of Education will comply to all provisions of P.L. 93-638 and to all provisions and regulations involved in securing other Federally funded funding, and

WHEREAS: THE Three Affiliated TRIBES believes that Pierre Indian Learning Center serves a needed service to the Indian Tribes of the Aberdeen Area,

NOW THEREFORE BE IT RESOLVED THAT THE Three Affiliated TRIBES go on record as supporting the Indian Board of Education for the Pierre Indian Learning Center in its endeavors to contract for Educational, Cooperative and Facility services with the Bureau of Indian Affairs and Health Services under the Indian Health Service. The Three Affiliated Tribes shall also go on record as supporting expansion of such programs at the Learning Center for the purpose of providing additional services for the Indian Children of the Aberdeen Area as mandated by the Indian Board of Education.

BE IT FURTHER RESOLVED that this resolution shall remain in effect and that the Pierre Indian Learning Center is authorized to contract with Indian Health Service and the Bureau of Indian Affairs until such time that said resolution is rescinded by the council action of the Three Affiliated Tribes

WE DO HEREBY CERTIFY THAT THE Three Affiliated TRIBES  
IN A DULY CALLED MEETING OF THE TRIBAL COUNCIL ADOPTED THIS RESOLUTION ON  
July 10<sup>th</sup>, 1986 AND PASSED IT BY A VOTE  
OF 17 IN FAVOR AND 0 OPPOSED.
