RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer any funds or property within the exclusive control of the Tribes and to make expenditures from available Tribal funds for the public purposes of the Tribes; and
- WHEREAS, Article IX, Section 6 of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to acquire by purchase any lands or interests in lands for and on behalf of the Three Affiliated Tribes; and
- WHEREAS, The Three Affiliated Tribes Alcoholism Program Director and staff have proposed, both to the Human Resources Committee and to the Tribal Business Council, the purchase of a house and two (2) lots situated within the City of New Town, North Dakota, in which house the Alcoholism Program intends to relocate its administrative offices; and
- WHEREAS, The Tribal Business Council has been informed that the purchase price of the house and two (2) lots is in the amount of Twelve Thousand and 00/100 Dollars (\$12,000.00), which real property is legally described as follows:

Lots 7 & 8 of Block 4 of Breslin's Subdivision of Township 152 North of Range 92 West of the Fifth Principal Meridian of the City of New Town, Mountrail County, North Dakota;

and

WHEREAS, The Tribal Business Council has been further informed by the Legal Department of the Three Affiliated Tribes that the Department has reviewed the abstracts of the real property involved herein and has determined that the current owner thereof, Louise Ruhland, maintains clear and good title to

said real property, without any encumbrances thereon constituted by unsatisfied judgments, mechanics or other liens, unpaid taxes, or unpaid special assessments; and

WHEREAS, The Tribal Business Council has reviewed the Warranty Deed drafted by the Legal Department, wherein Louise Ruhland will transfer title to the real property, legally described hereinabove, to the Three Affiliated Tribes for and in consideration of the sum of Twelve Thousand and 00/100 Dollars (\$12,000.00), a true and correct photostatic copy of which Warranty Deed is attached hereto and made part hereof;

NOW, THEREFORE, BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes hereby approves the purchase of the house and two (2) lots, legally described hereinabove, for the sum of Twelve Thousand and 00/100 Dollars (\$12,000.00) and authorizes the Three Affiliated Tribes Alcoholism Program to relocate its administrative offices in said house.
