RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer any funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for the public purposes of the Tribes; and
- WHEREAS, The Tribal Business Council, via Resolution #86-168-C, dated the 14th day of August, 1986, directed that the Fort Berthold Agency of the Bureau of Indian Affairs cause the monies in the total amount of Two Hundred, Thirty-Three Thousand, Eight Hundred, Forty-Two, and 68/100 Dollars (\$233,842.68) currently maintained in the Docket 350-G Litigation Fund in the Individual Indian Monies Account of the Three Affiliated Tribes to be forthwith transferred to the Three Affiliated Tribes Legal Department Account; and
- WHEREAS, The Fort Berthold Agency has informed the Tribal Business Council that the requested transfer has been accomplished and that the monies maintained in the Docket 350-G Litigation Fund are currently being maintained in a special bank account; and
- WHEREAS, The Tribal Business Council is currently in need of certain of the T2 funds previously allocated to the Legal Department in the FY 1986 T2 Expense Budget of the Council;
- NOW, THEREFORE, BE IT RESOLVED, That the Tribal Business Council hereby authorizes the Legal Department to commence expending the Docket 350-G Litigation Fund monies, as of September 1, 1986, so as to enable the Department to continue its work on pending legal matters during the balance of FY 1986.
- BE IT FURTHER RESOLVED, That the Tribal Business Council hereby authorizes and directs the Tribal Finance Office to revise the FY 1986 T2 Expense Budget of the Council to reflect a transfer of the amount of Nineteen Thousand, Sixty-Four, and

27/100 Dollars (\$19,064.27) from the Legal Department line item of the T2 Expense Budget to other line items of said T2 Expense Budget which are currently in need of supplementation.

BE IT FURTHER RESOLVED, That the total amount of the FY 1986 T2
Expense Budget of the Tribal Business Council [i.e., Six
Hundred, Seventy-Nine Thousand, Six Hundred, Seventy, and
00/100 Dollars (\$679,670.00)] shall not be changed as a
consequence of the transfer of funds therein as authorized
and directed hereby, as is reflected in the copy of the FY
1986 T2 Expense Budget-Revision #5 which is attached hereto.
