RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION



- WHEREAS. This Nation having accepted the Indian Reorgani THRE AFFILIATED TRIBES
 June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and Tribal members; and
- WHEREAS, Article VI, Section 5(b) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer any funds within the exclusive control of the Tribes; and
- **WHEREAS,** The Tribal Business Council has reviewed the FY1987 income projections as prepared by the BIA Agency Office New Town office; and
- WHEREAS, The Tribal Business Council accepts these projections for the Docket Funds;
- NOW, THEREFORE, BE IT RESOLVED. That the Tribal Business Council hereby approves the FY1987 Docket Funds Budget, a true and correct copy of which is attached hereto and made part thereof.
- **BE IT FURTHER RESOLVED,** That the Docket C/D funds for FmHA Land in the amount of \$26,600 be held in the current Investment account and remain in this account until the Tribe decides to draw these funds upon specific request in a future year.
