WHEREAS,	This nation having accepted the Indian Reorganization Act of June 18, 1934, and authority under said Act; and
WHEREAS,	The Constitution and By-Laws of the Three Affiliated Tribes authorize and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribe and tribal members; and
WHEREAS,	The Three Affiliated Tribes Tribal Business Council is the sole contractor of the Johnson O'Malley supplemental program having indicated a Tribal Home-School Coordinator under the direct supervision of the Three Affiliated Tribes Education Committee; and
WHEREAS,	The Tribal Home-School Coordinator will appoint a 5 member Johnson O'Malley Indian Education Committee on the ratio of 1 representative to every 100 students, respective to New Town Public School District #1, Parshall Public School District #3, and Head Start; pending an election at this ratio; and
WHEREAS,	The newly appointed JOM Indian Education Committee will work directly with the Tribal Home-School Coordinator meeting all requirements in CFR 25, and it is upon the negotiation between these said parties to decide stipend payment; and
WHEREAS,	A Johnson O'Malley application and income guidelines will be required to identify and direct supplemental monies to those who show financial need; and
WHEREAS,	The Tribal Business Council will approve foregoing payment of JOM office rent within the Tribal Administration building; and
WHEREAS,	The JOM Home-School Coordinator will submit a monthly narrative to the Tribal Education Committee with the option of calling 'special' meetings and
NOW THEREFORE	BE IT RESOLVED, that the Tribal Home-School Coordinator and the JOM Indian Education Committee have full authority to negotiate with Superintendents of Public School District #1 & #3, Head Start, and their respective school boards.
BE IT FURTHER	RESOLVED, that the Three Affiliated Tribes are committed to full development of educational opportunities to enhance and strengthen each child's opportunity for knowledge; moreover, we stand as active and informed participants. CERTIFICATION
