WHEREAS, There is a need to fill this position from within the membership of the Three Affiliated Tribes' Tribal Busines Council; and

WHEREAS, The Tribal Business Council of the Three Affiliated Tribes wishes to have two members of the Executive Committe serve as representatives to the United Tribes Educational Technical Center Board of Directors; and

NOW, THEREFORE, BE IT RESOLVED, That the Tribal Business Council hereby designates Tribal Chairman, Edward Lone Fight and Tribal Secretary, Ted Lone Fight III, as the representatives of the Three Affiliated Tribes to the United Tribes Educational Technical Center Board of Directors of North Dakota.
