RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
 - WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefits of the Tribes and of the enrolled members thereof; and
 - WHEREAS, The Natural Resources Committee has approved the exchange of lands between the Three Affiliated Tribes and Maxine Bolman, 301-U2224, under the terms and conditions stated below; and
 - NOW THEREFORE, BE IT RESOLVED, That the Tribal Business Council approves the exchange of lands, exclusive of minerals, held in trust by the United States of America for the Three Affiliated Tribes and lands held in trust by the United States of America for Maxine Bolman, 301-U2224, under terms and conditions as stated below and hereby authorizes the Chairman of the Tribal Business Council, its Secretary, and Superintendent of the Ft Berthold Agency, the Area Director, and the Commissioner of Indian Affairs or prepare all documents and to do all things necessary to exchange lands for which title is to be transferred to the United States of America in trust for the Three Affiliated Tribes and Maxine Bolman, under the terms and condition as stated below:

 - 711A W1/2SW1/4SE1/4,S1/2SE1/4SW1/4SE1/4,SE1/4NW1/4SE1/4,S1/2NW1/4 NW1/4SE1/4 2-149-94 ALL INTEREST CONTAINING 40 ACRES VALUED AT \$5,200.00.


