## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activites on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WWEREAS, It has come to our attention that the Bank of North Dakota is willing to consider working with the Bureau of Indian Affairs and the American Indian Agricultural Credit Consortium in making loans to our members under the Indian Financing Act; and
- WHEREAS, A part of this proposed agreement requires that loan packaging and management services be provided as required under the Indian Financing Act, to facilitate the loan; and
- WHEREAS, The inherent complexitites in loan packaging and management services for the type of loans to be restructured under this effort cost more money then the banks and lenders can afford; and
- NOW, THEREFORE, BE IT RESOLVED, That the Fort Berthold Agency Superintendent and the Area Director take appropriate action to provide on going technical assistance for this effort which is estimated to cost Fifteen hundred and 00/100 Dollars (\$1,500) per loan package; and
- BE IT FURTHER RESOLVED, That such funds be made immediately available so a technical resource can provide the services necessary to facilitate this program on the Fort Berthold Reservation.
