RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefits of the Tribes and of the enrolled members thereof; and
- WHEREAS, Federal and Private lending agencies have accelerated collections of loans to our members who have secured their mortgages with trust lands and are not aware of their rights under current statute and regulations; and
- WHEREAS, This tribe is aware that funding to provide technical assistance to our troubled Indian agriculturalists is not available in the Aberdeen Area; and
- WHEREAS, Many of our Indian agriculturalists are in danger of losing their trust lands but could otherwise survive if they had timely technical services and assistance; and
- WHEREAS, We are concerned that the available funding to provide these services has been placed with contractors who have stated that they are not able to assist us in the high plains area; and
- WHEREAS, Our Aberdeen Area Agricultural Development Committee has determined that there is an immediate need for one hundred twenty thousand dollars (\$120,000.00) to provide assistance in the first of a two year effort; and
- WHEREAS, This effort will provide resolution of the issues concerning trust land mortgages which should be a high priority issue with the Bureau of Indian Affairs; and
- NOW THEREFORE, BE IT RESOLVED, That the Assistant Secretary make available immediately one hundred twenty thousand dollars (\$120,000.00) so tribes can begin contracting to provide these needed services; and
- BE IT FURTHER RESOLVED, That a like amount of funds be set aside for the second year effort.
