
## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and Tribal members; and
- WHEREAS, Article VI, Section 5(b) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer any funds within the exclusive control of the Tribes: and
- WHEREAS, The Tribal Business Council has reviewed the information supplied to them by the Fort Berthold Agency of the Bureau of Indian Affairs regarding the status of residual IMPL funds; and
- WHEREAS, The Tribal Business Council has determined the need for additional funding for the administration of P.L. 93-638 funds by the appropriate Committees assigned this responsibility;
- NOW, THEREFORE, BE IT RESOLVED. That the Tribal Business Council hereby approves the following plan for the utilization of the residual IMPL funds available to them as stated by the Fort Berthold Agency of the Bureau of Indian Affairs:

All IMPL residual funds available to the Three Affiliated Tribes shall be utilized in support of general and incidental expenses in connection with the administration of B.I.A. P.L. 93-638 Contracts and Grants by the appropriate Committees.

All IMPL residual funds available to the Tribal Business Council shall be utilized in support of general and incidental expenses in connection with the administration of BIA P.L. 93-638 Contracts by the appropriate Committees.

As was discussed by the new Tribal Business Council during their April, 1987 meeting, enclosed is the required Resolution adopting this abovementioned plan.

Upon final acceptance by the BIA of this plan, we request these funds to be transferred to our bank account #8-229-6 with the Lakeside State Bank, New Town, North Dakota 58763.
