- NOW, THERFORE BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes, hereby authorizes payment of \$365.66 for services rendered during the month of December 1986 to Hobbs, Straus, Dean & Wilder Law Firm.
