- WHEREAS, Mr. and Mrs. Dennis Burr of Grand Forks, North Dakota request contract health services and fulfillment of medical prescriptions for their son Wayne Little Soldier, who is an enrolled member of the Three Affiliated Tribes, and is diagnosed as having impulsive Pettit Epilepsy; and
- WHEREAS, Mr. and Mrs. Dennis Burr requests this assistance because Mr. Burr is unemployed and Mrs. Burr is a full time Doctorial student and are unable to meet these obligations.
- NOW, THEREFORE, BE IT RESOLVED, That the Three Affiliated Tribes Tribal Business Council does hereby requests the Indian Health Service, Minne-Tohe Clinic provide contract and medical prescriptions for Wayne Little Soldier until the family is economically situated.

Dear Ed:

I am writing to you in reference to my step-son Wayne Little Soldier. On April 13, 1987, he was diagnosed at the Grand Forks Clinic in Grand Forks, North Dakota as having impulsive Pettit Epilepsy.

Since I am unemployed and his mother is attending Graduate School at the University of North Dakota we are unable financially to have him cared for medically as required. However, Wayne's father Gainus Little Soldier is a resident of Fort Berthold and under this condition we are requesting Contract Health Services from Fort Berthold.

Today, I requested Contract Health Services from Minne-Tohe through Reba Walker, Service Unit Director. She informed me that regardless of the age of the individual, the residency clause is in effect and services could not be provided to Wayne. I pointed out to her that his Father Gainus Little Soldier was responsible for child support for Wayne and that Gainus was a resident of Fort Berthold. She informed me that it made no difference where the father resided because Wayne was a non-resident.

I am, therefore, requesting from the Tribal Business Council a resolution in support of Wayne for Contract Health Services until such time as his Mother and I are re-employed and will purchase insurance to cover the medical expenses.

I wish to take this time and congratulate you and other members of the Council on your election victories and may the Great Spirit guide you on your decision-making of the many successes and obstacles you will endure in the time to come.
