## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5(a) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to manage all economic affairs and enterprises of the Tribes; and
- WHEREAS, Article VI, Section (c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer any funds within the exclusive control of the Tribes and to manage expenditures from available Tribal funds for the public purpose of the Tribes; and
- WHEREAS, The Fort Berthold Communications Enterprise, a Tribally-chartered nonprofit corporation dba Ahead of the Herd, tribal newspaper, is currently in need of supplemental funding to ensure continued development and operation of the tribal newspaper; and are seeking assistance from the FY 89 Telecommunication 350-G Docket funds; and
- WHEREAS, The Tribal Business Council has been assured by the Treasurer of the Council that the Three Affiliated Tribes shall be in receipt of land lease income in excess of Eight Thousand and 00/100 Dollars (\$8,000.00) on November 1989, on which date such funds shall become available to Tribes to be administered and used by the Tribal Business Council at its discretion, pursuant to its Constitutional authority as granted by Article VI, Section 5(c) of the Tribal Constitution; and
- WHEREAS, It is the considered judgment of the Tribal Business Council that it would be advisable to assign said land lease income as collateral for the loan proposed to be secured by Ahead of the Herd from the Union Bank of Halliday, North Dakota; and

- NOW THEREFORE BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes hereby authorizes Lisa Redford, Editor of the Ahead of the Herd newspaper a tribal business under the Charter of the Fort Berthold Communications Enterprise, forthwith take appropriate steps to secure from Union Bank of Halliday, North Dakota, a a loan in the amount of Eight Thousand and 00/100 (\$8,000.00), total amount of said loan to be Eight Thousand and 00/100 Dollars (\$8,000.00) the for the benefit of Fort Communications Enterprise dba Ahead of the Herd. Lisa Redford shall be authorized to execute notes herein on behalf of the Fort Berthold Communications Enterprise, Tribal Newspaper.
- BE IT FURTHER RESOLVED, That the Tribal Business Council hereby authorizes that the land lease income in the amount of Eight Thousand and 00/100 dollars (\$8,000.00) be assigned as collateral for the proposed loans herein.
- BE IF FURTHER RESOLVED, That this note will be repaid from the FY 89 Telecommunications 350-G Docket Funds in the amount of Eight Thousand and 00/100 Dollars (8,000.00).
- BE IT FURTHER RESOLVED, That the interest in the approximate amount of \$1,300.00 for the Ahead of the Herd loan shall be payable, inclusive to the \$8,000 loan, from the Docket 350 G Telecommunications line item.
