- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and authority under said Act; and,
- WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes authorized and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and Tribal members; and,
- WHEREAS, The Contractor agrees to establish and maintain an Adult Basic Education program in its service area and area of jurisdiction in accordance with the needs of it's communities; and,
- WHEREAS, The Three Affiliated Tribes desires to contract, under Public Law 93-638, the Adult Education Program from the Bureau of Indian Affairs for Fiscal Years 1988, 1989, and 1990; and
- WHEREAS, The Contractor agrees to recontract each year as required; and
- WHEREAS, The Bureau of Indian Affairs advises that the Contractor submit a program budget based on 75 percent of the tentative Fiscal Year 1988 allocations;
- NOW THEREFORE BE IT RESOLVED, That the Three Affiliated Tribes under the authority of Public Law 93-638 submits this contract application for the first year of the three-year contract period, which begins on October 1, 1987 and ends on September 30, 1988.
- BE IT FURTHER RESOLVED, That the Chairman, Vice-Chairman, Secretary or Treasurer shall be allowed to negotiate and sign on behalf of the Tribal Affiliated Tribe's Tribal Business Council.
