- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 (d), of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to negotiate with the Federal and State governments on behalf of the Three Affiliated Tribes; and
- WHEREAS, Article VI, Section 5 (j), of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to protect and preserve the property, wildlife and natural resources of the Tribes; and
- WHEREAS, This License, for Skunk Creek Bay, from the Corps of Engineers is for the construction of a boat ramp, parking lot and access road, which provides employment to Tribal members and a Tribally controlled access to Lake Sakakawea; and
- NOW THEREFORE BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes, Tribal Business Council hereby formally approves the Department of the Army License for 24' wide boat ramp, 650 feet of road, and a 140 foot by 200 foot parking area, No.
