RESOLUTION OF THE GOVERNING BODY  
OF THE  
THREE AFFILIATED TRIBES  
OF THE  
FORT BERTHOLD INDIAN RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 (i) of the Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to make assignments and leases of tribal lands, in accordance with the provisions of Article IX; and
- WHEREAS, Several allotments in which the Three Affiliated Tribes own and undivided interest in are either unleased or the lease will expire on December 31, 1987; and
- WHEREAS, The Tribal Business Council desires that these lands be leased;
- NOW THEREFORE BE IT RESOLVED, That Tribal Business Council of the Three Affiliated Tribes hereby authorizes the Superintendent of the Fort Berthold Agency to advertise for lease to the general public the allotments listed on the attached sheet.

C E R T I F I C A T I O N
