WHEREAS，The Natural Resources Committee has approved the Exchange af lander between the Three Affiliated Tribes能 fiffman Eagle，under the terms and conditions stated below：and

NOW THEREFGRE，EE IT FESGLVED，That the Tribal Business Council approves the exchange of lands，exclusive af minerals， held in trust by the United States of America for the Three Affiliated Tribes and lands held in trust by the United States af America far Carman Eagle，Jai－U609， under terms and conditions as stated below and hereby authorized the Chairman of the Tribal Business Council． its Secretary，and Superintendent of the Fort Berthold Agency，the Area Director，and the Commissioner of Indian Affaire ta prepare all documents and to do all things necessary to exchange lands for which title is to be transferred to the Tribe and Carman Eagle，under the terms and condition as stated below：
