- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and Tribal members; and
- WHEREAS, The Three Affiliated Tribes' Tribal Business Council has reviewed the FY 1988 income projections as prepared by the Fort Berthold agency office of the Bureau of Indian Affairs, a true and correct copy of which is attached hereto and made part thereof; and
- WHEREAS, The Tribal Business Council recognizes the total income projected may be sufficient to support the immediate needs of the Tribal Government for FY 1988;
- NOW, THEREFORE, BE IT RESOLVED, That the Three Affiliated Tribes Tribal Business Council hereby approves the attached FY 1988 T2 expense budget in the amount of \$499,351.00, a true and correct copy of which is attached hereto and made a part thereof.

BE IT FURTHER RESOLVED, That the required cash draws from the Tribes' IIM accounts maintained at the Fort Berthold agency office of the Bureau of Indian Affairs will be \$227,000.00, \$236,000.00 will be from the Tribes' account #7228 maintained by the U.S.Treasury and \$36,351.00 will be from Tribal money market investment income, for a total of \$499,351.00.
