RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Three Affiliated Tribes have been invited by the Department of Housing and Urban Development, Office of Indian Programs to submit a application for a grant to fund eligible Community Block Grant Activities for Fiscal Year 1988; and
- WHEREAS, The Tribal Business Council must specify its requested activities, set priorities for these activities, and make certain assurances in compliance with Department of Housing and Urban Development regulations; and
- NOW THEREFORE BE IT RESOLVED, That after thorough consideration of all community development needs within the Fort Berthold Reservation, The Tribal Business Council directs the respective departments and communities to execute and file an application for financial assistance under the Community Development Block Grant Fiscal Year 1987 Program for the following proposed activity:

Twin Buttes Community Building - Number 1 Priority Construction of Sanitary Landfill - Number 2 Priority Housing Duel Fuel Modification - Number 3 Priority Mandaree Recreation Project - Number 4 Priority

- FURTHER RESOLVED, That the Tribal Business Council hereby certifies that the requirements of 24 CFR 571.604 (a) through (c) have been complied with the development of this application to insure adequate citizen participation and that at least 51% of the proposed project beneficiaries will be low and moderate income people.
- FURTHER RESOLVED, That the above requirements and all other understandings, certifications, and assurances contained in the application shall be continued to be complied with throughout the term of the FY 1988 Grant.
