RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 (d), of the Constitution of the Three
 Affiliated Tribes specifically authorizes and empowers the Tribal
 Business Council to negotiate with the Federal and State governments
 on behalf of the Three Affiliated Tribes; and
- WHEREAS, Article VI, Section 5 (j), of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to protect and preserve the property, wildlife and natural resources of the Three Affiliated Tribes; and
- WHEREAS, The Three Affiliated Tribes have negotiated the terms and conditions of License No. DACW45-3-87-6142 with the Department of the Army; and
- whereas, One of the conditions of said license is that the Tribes obtain public access to the proposed recreation area at Skunk Creek Bay; and
 - WHEREAS, The Three Affiliated Tribes have granted public access right-of-ways across certain tribal lands near Skunk Creek Bay to Three Affiliated Tribes; however, the Bureau of Indian Affairs requires that if the Tribes waive the payment for the right-of-way a Tribal Resolution must be passed affirming the grant.
 - NOW THEREFORE BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes hereby grants a twenty five year right-of-way, one hundred and fifty feet wide, for public access across the following allotments: 2214, 2215, 1005A, 604A, 603A, 602A, 2131, and agrees to waive payment for said right-of-way.
