RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribes and tribal members; and
- WHEREAS, It is the declared policy of the U.S. Congress to provide capital on a reimbursable basis to help develop and utilize Indian resources, both physical and human, to a point where the Indian will fully exercise responsibility for the utilization and management of their own resources and where they will enjoy a standard of living from their own productive efforts comparable to that enjoyed by non-Indians in neighboring communities; and
- WHEREAS, The Indian Financing Act of 1974(Public Law 93-262) was signed into law on April 12, 1974; and
- WHEREAS, The Indian Financing Act Amendments of 1984(Public Law 98-449) were added to augment and expand the original legislation on October 4, 1984; and
 - WHEREAS, Together, these laws are the basis for providing funds to Indians for economic development projects and business ventures; and
 - WHEREAS, These funds are administered by the Division of Financial Assistance, Bureau of Indian Affairs, and are available in the form of direct loans, loan guaranties, and non-reimbursable grants to qualifying Indian organizations; and
 - WHEREAS, Dale McGrady(an enrolled tribal member) and Mandaree, Inc. shall own and control 52% of the common and Preferred Stock of Manceram, Inc.
 - NOW THEREFORE BE IT RESOLVED, The Three Affiliated Tribes recognizes Manceram, Inc. as a Indian organization incorporated in the State of North Dakota as a Indian owned and controlled economic enterprise; and
 - BE IT FURTHER RESOLVED, The Three Affiliated Tribes encourages and supports the efforts of Manceram, Inc. to secure financing through the Indian Financing Act (P.L. 93-262 and P.L. 98-449).
