  Council to engage in activities on behalf of and in the interest of the welfare and benefits of the Tribes and of the enrolled members thereof. WHEREAS, The Constitution of the Three Affiliated Tribes interest of the wellare and benezits of the enrolled members thereof; and
- WHEREAS, The Natural Resources Committee of the Tribal Business
  Council approved the purchase of land described below;
- WHEREAS, It has been determined that it is in the best interest of the Tribe to acquire the land; and
- That the Three Affiliated Tribes NOW THEREFORE, BE IT RESOLVED, Tribal Business Council approves the purchase of lands Take the described below, exclusive of minerals, from

for cash consideration of \$11,000.00 which is the present fair market value, utilizing funds from the FmHA Land Purchase account. and hereby suthers and the second present fair market value, utilizing funds from the rmna Land Purchase account, and hereby authorized the Chairman of the Tribal Business Council, its Secretary, and Superintendent of the Fort Berthold Agency, the Area Director, and the Commissioner of Indian Affairs to prepare all documents and to do all things necessary to transfer title of the lands to the United States of America in trust for the Three Affiliated Tribes of the Fort Berthold Indian Reservation, to wit.

Fee - Block 39, Lots 3, 4, 5, 6 and 7 (with house located on Lot 7) surface and minerals, valued at \$11,000.00
