RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the health, welfare, and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Three Affiliated Tribes' Tribal Business Council wishes to maintain the Research Paralegal position within the Three Affiliated Tribes' Legal Department; and
- WHEREAS, The Three Affiliated Tribes' Tribal Business Council has reviewed the present financial status of the Research Paralegal position of the Three Affiliated Tribes' Legal Department in light of contractual oversight responsibilities and tenure at that position subsequent to the development of projects under the direction of the Three Affiliated Tribes' Legal Department; and
- WHEREAS, The Tribal Business Council agrees that the salary of this Research Paralegal position held presently by Roger Bird Bear be commensurate with the education and experience he puts forth in his responsibilities and duties as the Research Paralegal; and
- WHEREAS, The income increase to meet tenure and education justifications will be set at \$18,500.00 for Roger Bird Bear, effective 1 October 1988 for fiscal year 1989 until 30 September 1989.
- NOW THEREFORE BE IT RESOLVED, That the Three Affiliated Tribes' Tribal Business Council hereby approves the salary increase to \$18,500.00 for fiscal year 1989 to be financed from the Water Rights Negotiation Coordination Grant as authorized by Pub. L. 93-638.
