WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and Tribal members; and
- WHEREAS, The Three Affiliated Tribes' Tribal Business Council has reviewed the FY 1989 T-2 projected income, in the amount of \$ 463.000.00, as estimated by the Bureau of Indian Affairs (BIA), Fort Berthold Agency (Agency), and \$ 35,000.00 of miscellaneous income from Tribal interest bearing accounts, as presented by the Tribal Treasurer.
- NOW, THEREFORE, BE IT RESOLVED, That the Three Affiliated Tribes Tribal Business Council hereby approves the attached budget which utilizes the estimated FY-1989 funds in the amount of \$ 463,000.00 from the Tribes' IIM accounts maintained by the BIA at the Agency (#S-541 and S-542) and the U.S. Treasury (#7228), and the estimated interest and miscellaneous income earned by the Tribes in the amount of \$ 35,000.00, for a total of \$ 498,000.00.

BE IT FURTHER RESOLVED, That the budgetary needs for FY-1989 requires additional income from the BIA accounts, #S-541, #S-542 and #7228, in the amount of # 32,133.
