## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and Tribal members; and
- WHEREAS, The Three Affiliated Tribes' Tribal Business Council has reviewed the status of the Docket 54-81L Hospital Funds as reported by Mr. Earl Azure, BIA AAO Tribal Government Department, and as presented by the Tribal Treasurer; and
- WHEREAS, The Three Affiliated Tribes' Tribal Business Council has recognized and accepted the determination made by Mr. Azure, and as agreed to by his Solicitor, as stated to the Tribal Comptroller via telecon on December 14, 1988, at 1:08 PM, that these Hospital Funds are available for programming, as deemed necessary, by the Tribes because the mandatory five (5) year restriction from use has expired in August, 1988.
- NOW, THEREFORE, BE IT RESOLVED, That the Three Affiliated Tribes Tribal Business Council hereby states that these Hospital Funds from 54-81L are to be used as follows:
  - 1. \$33,937.87 to be repaid to Docket 350-C/D principal to complete the pay back in full of the \$219,355.87 erroneously withdrawn and paid to the Tribes in 1985.
  - 2. \$ 131,392.17 plus interest earned from investments which matured November 17, 1988, and any future interest earned from overnighter and/or other investments at the time of the withdrawal of these funds, shall be used to purchase lots within the cities of New Town and Parshall.
- BE IT FURTHER RESOLVED, That this Council hereby directs the Bureau of Indian Affairs to have withdrawn and deposited, to the Three Affiliated Tribes bank account with the First American Bank of Minot, these finds currently accounted for in Treasury accounts #9028-2610 and 9528-2610 on the date of the current investments' maturity date.
