

RESOLUTION OF THE GOVERNING BODY OF  
THE THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefits of the Tribes and of the enrolled members thereof; and

WHEREAS, The Natural Resources Committee of the Tribal Business Council approved the purchase of land described below; and

WHEREAS, It has been determined that it is in the best interest of the Tribe to acquire the land; and

NOW THEREFORE, BE IT RESOLVED, That the Three Affiliated Tribes Tribal Business Council approves the purchase of land, exclusive of minerals, from

VERNON BIRDSBILL : 301-U1258

for cash consideration of \$3,269.14 which is a negotiated value, utilizing \$2,769.14 from the FmHA Land Purchase account and \$500.00 from the Docket 350-G Land Purchase account and hereby authorizes the Chairman of the Tribal Business Council, its Secretary, and Superintendent of the Ft Berthold Agency, the Area Director, and the Commissioner of Indian Affairs to prepare all documents and to do all things necessary to transfer title of the lands to the United States of America in trust for the Three Affiliated Tribes of the Fort Berthold Indian Reservation, to wit.

- 1384 E1/2NE1/4 9-148-90 containing 80 acres, selling an undivided 4/81 interest, containing 3.95 acres valued at \$820.74
- 462A W2NW1/4, SW1/4, W2SE1/4 9-148-90 containing 320 acres, selling an undivided 4/81 interest, containing 15.80 acres valued at \$2,448.40




