- WHEREAS, The Three Affiliated Tribes' Tribal Business Council has reviewed the status of the FY-1989 Docket Funds budgeted position as presented by the Tribal Treasurer; and
- WHEREAS, The Three Affiliated Tribes' Legal Department is in need of additional funding to recover the loss of the \$ 25,000.00 it had to relinquish to the T-2 budget; and
- WHEREAS, The Docket 350-C/D Insurance program has funds budgeted in excess of need; and
- WHEREAS, The Docket 350-C/D Federal Register allows legal costs to be budgeted as a program within this docket.
- NOW, THEREFORE, BE IT RESOLVED, That the Three Affiliated Tribes Tribal Business Council hereby approves the amended budget for Docket 350-C/D Funds for FY-1989 reallocating \$ 25,000.00 from the Insurance program to the Legal program.
