RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE

FORT BERTHOLD INDIAN RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 (d) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to negotiate with the Federal and State governments on behalf of the Three Affiliated Tribes; and
- WHEREAS, Article VI, Section 5 (j), of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to protect and preserve the property, wildlife and natural resources of the Three Affiliated Tribes; and
- WHEREAS, Lease No. DACW 45-1-89-6091 when issued by the Department of the Army will allow for construction of a boat ramp, boat dock, parking lot, access road, and other recreational facilities which will provide for employment and recreational opportunities for tribal members and tribally controlled access to Lake Sakakawea; and
- NOW THEREFORE BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes hereby approves Lease No.

 DACW 45-1-89-6091 and authorizes the Tribal Chairman to sign the lease on behalf of the Three Affiliated Tribes.
- BE IT FURTHER RESOLVED, That Tribal Business Council of the Three Affiliated Tribes, pursuant to Chapter 1, Section 1.2 and 3.6 (1) of the Code of Laws of the Three Affiliated Tribes of the Fort Berthold Indian Reservation, hereby expressly waives the Tribes Sovereign immunity from suit relative to Lease herein and consents to be sued in it's corporate name upon any claim or obligation arising from or incident to the terms of Lease herein.
