Resolution of the Governing Body of
The Three Affiliated Tribes of the
Fort Berthold Reservation

- Whereas, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- Whereas, The Constitution of the Three Affiliated Tribes generally authorized and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and Tribal members;
- Whereas, The Three Affiliated Tribes is experiencing a severe problem with alcohol/drug abuse amongst the youth on Fort Berthold Reservation; and
- Whereas, The Three Affiliated Tribes Tribal Business Council in conjunction with Indian Affairs Commission Office, Bismarck, North Dakota agrees to the 1989-1991 Biennium Budget for the benefit and welfare of the youth on Fort Berthold Reservation; and
- Whereas, Growth and Development Program has been established as the Native American Drug and Alcohol educational agency for the Three Affiliated Tribes; and
- Whereas, Growth and Development prepares children of the Three Affiliated Tribes--particularly from disadvantaged families--for lifelong benefits including decision making for the most appropriate life choices, ie, finishing school, college, career options, marriage; and
- Whereas, The current resident Indian population is estimated to be 3,310 persons and a portion of this amount are our youth located in the (5) five segments of the Reservation; and
- Whereas, Our Children are this Nation's number one priority.

Now, Therefore be it resolved, that the Tribal Business Council in the best interest of its youth request that the 1989-1991 Biennium Budget by the Growth and Development Program be approved of \$72,904.00.



C E R I F I C A T I O N


