RESOLUTION OF THE GOVERNING BODY OF
THE THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in the activities on behalf of and in the interest of the welfare and benefit of the tribes and of the enrolled members thereof; and
- WHEREAS, Article IV, Section 5 (d), of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to negotiate with the Federal and State governments on behalf of Three Affiliated Tribes; and
- WHEREAS, Article VI, Section 5(j), of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to protect and preserve the property, wildlife and natural resources of the Three Affiliated Tribes; and
- WHEREAS, The Three Affiliated Tribes understands that funding reductions are proposed by the Bureau of Indian Affairs, Fish, Wildlife and Parks trust office for fiscal year 1991; and
- WHEREAS, The Three Affiliated Tribes also understands that during fiscal year 1991 the Bureau of Indian Affairs Fish, wildlife and Recreation Trust office has requested a funding increase for the central office while reducing funds for Tribal management programs; and

WHEREAS, The Three Affiliated Tribes and its Natural Resources Department are competent resources managers and require additional funds for fish, wildlife and recreation management not a reduction in funding as proposed in the FY 1991, Bureau of Indian Affairs Fish, Wildlife and Recreation budget proposal; and

NOW THEREFORE, BE IT RESOLVED, That the Three Affiliated Tribes oppose such funding reductions to fish, wildlife and recreation programs at the Tribal level while increasing funding for operation at the central office of Fish, Wildlife and Recreation Trust; and

BE IT FURTHER RESOLVED, That the three Affiliated Tribes requests that funding for fish, wildlife and recreation programs at the Tribal level receive an increase to continue developing and implementing practices on the Fort Berthold Reservation.
