

**RESOLUTION OF THE GOVERNING BODY OF
THE THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION**

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, the Docket 350-C&D Community Development Funds for Fiscal Year 1990 were made available and \$103,862 was identified by Tribal Resolution #89-256-TL which allocated Docket Income, and Resolution #90-97-TL divided that amount into Community allocations; and

WHEREAS, at the Tribal Business Council of May 10, 1990 Council member discussion took place concerning the headcounts and Community allocation amounts with the resulting decisions being:

- o White Shield's new count of 504 persons was accepted
- o No payments will be made until a revised 1990 CD Fund Resolution is passed
- o The Mandaree Community was to set aside at least \$5000 in case it had received an overpayment and had to repay
- o The Community Census lists of Mandaree, Four Bears, and Twin Buttes were to be checked by the BIA Enrollment Office for accuracy
- o Tribal Council members were to remind their Community Boards of any headcount or audit records deficiencies
- o The new allocation should be a straight community population percentage of total with no complicating delinquency factors, etc.

WHEREAS, The required submission of audit materials by some communities has remained incomplete with no change since the May 10 Council Meeting - (Yes = Received) (No= Not Provided By Community) (CD = Docket Community Development Funds) (RS = US Revenue Sharing Funds):

WHEREAS, The Tribal Business Council does not wish to assume liability for the unauditable accounts of the Reservation Communities and have to utilize T-2 Funds to correct any questioned costs, etc.; and

WHEREAS, The new population figures and percentages for FY 1990:

WHEREAS, Certain of the communities have received loans or advances on their 1990 CD funds, or received an excess amount of 1989 or 1990 Funds by mistake,

NOW, THEREFORE, BE IT RESOLVED, that until they have provided ALL of their required headcount and audit information, the Communities shall be eligible to receive only the fraction or proportion of the Docket 350-C&D Community Development Funds that is comparable to the amount of audit information they currently have delivered minus any obligations or advances,

FURTHER BE IT RESOLVED, that the Communities shall be required to to utilize the attached Request/Notification Form to request Fiscal Year 1990 Docket 350-C&D Community Development Funds

FURTHER BE IT RESOLVED, that the Twin Buttes Community has submitted the required headcount and bookkeeping information and has no obligations against its CD funds so it may, at any time, request a draw down of its allocation of:

FURTHER BE IT RESOLVED, that the Northeast Segment Community has:

- not submitted its required headcount
- submitted only 1/9th (1987-88) of its required bookkeeping records
- was delinquent in submitting its Peoples Bank & Trust loan papers and documentation for its \$2,500 loan which resulted in the Three Affiliated Tribes not being able to pay off the loan in a timely manner (Total Payoff \$2,745.75)
- received excess 1989 CD funds in the amount of \$1,452.51 which will be subtracted from the 1990 funds

FURTHER BE IT RESOLVED, that the White Shield Segment has:

- not submitted its required headcount
- submitted only 3/9ths of its required bookkeeping information
- received a \$5,000 advance drawdown
- received excess 1989 CD funds in the amount of \$2,704.79

FURTHER BE IT RESOLVED, that the Mandaree Community has submitted the required headcount and bookkeeping information and did request a drawdown in the amount of \$24,028.64 of its allocation minus its loan payment made to First International Bank Of Watford City by the Three Affiliated Tribes:

1. The Community shall not receive the balance of the FY 90 CD Funds authorized by Resolution until ALL of the Required Audit Information for Community Development Funds FY 1983-FY 1989, US Revenue Sharing Funds FY 1983-1985, and headcount information is received.
2. The following FY 1990 (January 1, 1990 through December 31, 1990) Audit and Recordskeeping Information shall be required prior to the disbursement of the Fiscal Year 1991 Docket 350-C&D Funds:
 - A. Community Meeting Minutes
 - B. Bank Statements
 - C. Bank Reconciliations
 - D. Cash Receipt Records
 - E. Cash Disbursement Records(These should be provided no later than January 15, 1991 so that they may be made available to the Tribe's Auditors)
3. Community Census List Requirements are:
 - A. Conduct a Head Count restricted to Enrolled Tribal Members Residing within the Community
 - B. Prepare 26 Sheets of Paper to compile your lists on. At the top-middle of each sheet you should write the Name of the Community and the appropriate letter of the Alphabet. The 1st Sheet would have " _____ " Community and "A" at the top, and so on, through the 26th Sheet which would have the Community Name and "Z" at the top.
 - C. Each resident enrolled member's Full Name shall be entered upon one of the sheets, alphabetically by last name, in the following manner:
Last Name, First Name

- D. Additionally, once each sheet listing is complete, the names listed on that sheet should be placed in alphabetical order.
- E. One copy of this 26 Page Document shall be submitted to the Secretary of the Tribal Business Council prior to October 15, 1989.
