## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Three Affiliated Tribes have completed a study of the legal and jurisdictional issues relating to the administration of the transportation systems on the Fort Berthold Reservation; and
- WHEREAS, The Three Affiliated Tribes Business Council by resolution # 88-37-TL formally adopted and enacted the "Three Affiliated Tribes Highway Ordinance" which establishes a Tribal Highway Department capable of managing the transportation system on the Fort Berthold Reservation; and
- WHEREAS, The Three Affiliated Tribes Business Council needs certain information regarding the operation and financing of the Bureau of Indian Affairs road construction and maintenance programs to properly determine whether to enter into a P.L. 93-638 Contract with the Bureau of Indian Affairs for the management of these programs;
- NOW, THEREFORE, BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes, pursuant to the regulations of P.L. 93-638, hereby request the following information on the road construction and maintenance programs from the Bureau of Indian Affairs:
  - Organization list of all positions and salaries of all staff at the agency and area level.
  - Funding list of all sources of funding and methods for determining annual program amounts.
  - 3. Equipment list of all heavy equipment on the Fort Berthold Agency inventory.
  - 4. Facilities list of all office space and equipment utilized for the programs.

BE IT FURTHER RESOLVED, That the Bureau of Indian Affairs respond to this request in accordance with the regulations of P.L. 93-638.
