RESOLUTION OF THE GOVERNING BODY OF
THE THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION

WHEREAS, This Nation, having accepted the Indian Reorganization Act of June 18, 1934, and the Authority under said Act; and

WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribes and Tribal members; and

WHEREAS, The Three Affiliated Tribes, Human Resources Department is established to increase the Three Affiliated Tribes, Tribal Business Council's capacity of providing more accessible, effective and diversified Health and Human Services; and

WHEREAS, The Three Affiliated Tribes, Human Resource Department recognizes the need to continue and provide selected health services throughout the Reservation; and

WHEREAS, The selected Health services are based on critical health needs of specific vulnerable groups of Tribal members that are identified by the Health and Human Service Program components in the Human Resource Department;

NOW, THEREFORE BE IT RESOLVED, That the Three Affiliated Tribes, Human Resource Department will continue to strengthen existing health services through the continuation of the Combined Health Services, Master Contract with the Indian Health Service;

BE IT FURTHER RESOLVED: That there are no changes in the FY-91 budgets except the Community Health Representative Program, a Matrix system has been incorporated in the Scope of Work;

BE IT FURTHER RESOLVED: That the Indian Health Service will provide funding at the following amounts: Alcoholism Program, \$200,728.78; Community Rehab. and Aftercare, \$53,200.00; Physicians Extender Program, \$198,621.27; Tribal Health Administration, \$30,784.00; Janitorial/Custodian Program, \$22,217.00; Community Health Representative Program, \$244,531.38 for a total of \$750,082.43. The indirect cost of 36% is included.
